Delta ltd

An American mega company known as Delta ltd specialized in wood business came up with a project. The project consists in exploiting wood in the African equatorial forests. The project involves the identification of commercial trees, the cutting of the trees, and the transformation of the trees into different wooden finished products to be sold in Africa and in big cities across the world. At the same time the mega project includes tree plantation to replace not only the trees which are cut but also to sustain the ecosystem and biodiversity by planting varieties of trees. The project was set with an initial capital of 100 Billion \$, with a net government profit of 25 billion \$ per semester, and was supposed to create thousands of jobs for the host government and the villagers living in the surrounding. The project equally has a component of social responsibility with the constructions of schools, well equipped hospitals, road construction, opened-markets sites for the villagers, clean water provision centers, a well-furnished game park with different game activities, and training centers to skill the villagers into the new technologies like computers, electronic gadgets etc. The republic of Cameroun was identified. The project site was the equatorial forest where the pygmies have been living for decades. The Cameroonian minister in charge of approving the project for its implementation requested half of the total project investment cost. Surprised and discouraged, the Delta Company ended the initiative and returned back to America.
