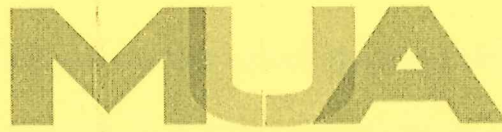

QUESTION ONE

Read the attached case study below and answer the questions that follow

In 1998 a Maasai member of Seventh Day Adventist Church Ngong Hills called Mrs. Lucy ole Nchoki requested the church to open in her home area in order to take the message she had received after giving her life to Christ and eager not go to heaven alone. The church administrative staff lead by elder Kinara visited her home area and arranged for an evangelistic public meeting. A proposal through the Seventh Day Adventist Church Ngong Hills was made to the members who in turn supported the idea, under then the Church Pastor David Wabwire. A public evangelistic meeting was conducted for 3 weeks and 50 members accepted God's message and eleven among them were baptized.

The sponsor, Seventh Day Adventist Church, Ngong Hills remains guided by the great commission as recorded in the book of Matthew 28:19. Our evangelistic program since 1998 has seen several churches being planted. The organized Churches were brought land and structures for worship were put for worship and this was being done as the main church remained temporary. The organized Churches:- Seventh Day Adventist Church Matasia, Seventh Day Adventist Church Embul Bul, Seventh Day Adventist Church Oololua, Seventh Day Adventist Church Kerarapon, Seventh Day Adventist Church Kangundo.

In addition to the Churches, we run Sabbath Schools name at Oololaise High School, Kenya Highway Building Institute Kibiko and Olgumi which is to be organized into church after his year. We expect to open a Sabbath School later this year in Kibiko were we have already purchased land for the purpose. These efforts have cost the sponsor than seven million.

The sponsor is currently buildirg sanctuary and more than fifteen million (Kes 15m) has been used and a further ten million (Kes 10m) is required to complete the works.

This project has strained the church to the extent that they are not able to support Olgumi Centre of Influence.

The salaries of the teachers remain unpaid since January 2012 after the money provided by EACD was exhausted. The inability to support the Centre is not being received well by the community who donated the land and as a result another Church (African Inland Church) is running the school feeding programme. There was an attempt to take over the school only to realize that the Title belongs to Seventh Day Adventist Church.

The Centre has outgrown its financial ability more so because of the resources required to actualize the completion of the sanctuary which has taken over six years to the present stage. In order to achieve the primary objective of the Centre, the centre's recurrent expenditure has to be met. In addition there is basic infrastructure to be completed for the Centre to function and to improve the image of the Adventist in the local community.

The teachers' salaries which have been outstanding since January 2017 need to be paid urgently. The teacher pupil ratio is also not within the recommended threshold. It is evident that we are not complying with the Governments requirement which we should as responsible citizens as Christ did! Besides some of the incomes projected is dependent on some activities mentioned being undertaken. A conservative budget of about USD 60,000 will help meet the recurrent expenditure for the first year and depending on whether some income generating activities are funded. Volunteer will help reduce cost of running the centre.
